Competition notice for admission to the "Specialization School in Architectural Heritage and Landscape" for the academic year 2018/2019 at Politecnico di Bari – Department ICAR.

Art.1 **Establishment and subject of the Selection Call**

The public competition, based on qualifications and examinations and opened to Italian and foreign citizens, is announced for admission to the "Specialization School in Architectural Heritage and Landscape" for the academic year 2018/2019 at Politecnico di Bari – Department ICAR.

The maximum number of candidates eligible for the 1^{st} Year is n. 30, n. 2 of which can be foreign candidates from non-EU Countries.

The different rules of participation in the competition and the completion of the related call procedure for non-EU foreign candidates are explained by Article 5 of this Call.

The Course will start on January 2019.

The duration of the study program is 2 academic years and requires the acquisition of total 120 CFU.

Art. 2 **Purpose of the Specialization School**

The School aims to train specialists with a specific high professional profile in the field of study, protection, restoration, management and enhancement of architectural and landscape cultural heritage, in its broadest sense.

The "Specialization School in Architectural Heritage and Landscape" at Politecnico di Bari is divided into 3 different curricula, on the base of the specific knowledge held by Department ICAR:

- a. Curriculum in History and restoration of ancient architecture;
- b. Curriculum in Restoration of stone architecture;
- c. Curriculum in Landscape Analysis and Restoration.

Art. 3 **Requirements for participation**

The participation application to the "Specialization School in Architectural Heritage and Landscape" can be submitted by candidates who hold one of the following degree:

- \circ Degree awarded by the education system prior to the Italian Ministerial Decree dated November 3, 1999 n. 509 in
 - Architecture;
- o 2nd cycle two years degree (*laurea specialistica*) obtained under the Ministerial Decree 3.11.1999 n. 509, or 2nd cycle two years degree (*laurea magistrale*) obtained under the Ministerial Decree 22.10.2004 n. 270 in
 - Architecture and Civil Engineering (classe S/4)
 - Architecture and Construction Engineering-Architecture (classe LM-4)

In addition, after evaluation by the School of personal curricula, to identify any educational debits, it is possible to admit candidates with a second level degree in the following classes:

- Archaeology (classe 2/S) (classe LM-2);
- Preservation of architectural and environmental heritage (classe 10/S) (classe LM-10);
- Preservation and restoration of the historical and artistic heritage (classe 12/S);

- Preservation and restoration of cultural heritage (classe LM-11);
- History of Art (classe 95/S) (classe LM-89).

In addition, it is possible to admit for the selection candidates with degree titles of the previous education system assimilated to those of the new education system indicated as a requirement of admission according to what established by the table of equivalence issued with D.I. May 5, 2004, without prejudice to the specific curricula requirements above mentioned and Italian and foreign citizens with academic qualification obtained abroad (i.e. II Level Degree: Master's Degree, Master of Science/Art, other.)

Candidates already in the possession of the certification of equivalence of the qualification awarded by an Italian university must attach the related self-certification to the application for admission to the competition (provision number etc...)

In case of academic qualification obtained abroad that has not been recognized equivalent to degrees, the suitability will be assessed by the Selection Committees on the base of the current national legislation and the legislation of the Country in which the academic qualification has been awarded and on the base of treaty and international agreements as regards the recognition of title for further education.

For the purpose of this recognition, candidate must attach to the online application any other document suitable to prove the required equivalence of the academic qualification.

The admission of all candidates is subject to confirmation as regards the assessment of the requirements for participation that Politecnico di Bari can verify in any moment and even after the study program has already started, according to art. 43 of T.U. n. 445/2000. At any time, candidates can be excluded with reasoned provision.

Art. 4 Application submission procedure and deadline for application

The candidate can apply for Specialization School from October 6, 2018 to November 5, 2018 only through the application available to web-site www.poliba.it, path DIDATTICA - PORTALE DEGLI STUDENTI ESSE3.

All communications related to this competition will sent to candidate by e-mail by using the e-mail address the candidate has indicated in the online application.

Any applications submitted in different ways will not be taken into consideration.

It is responsibility of the candidate to verify the correct conclusion of the procedure. Applicants are invited to apply for the competition sufficiently in advance before the deadline.

In order to access to the online application, the candidate must first register to ESSE3 system. In case the applicant have never registered at Politecnico di Bari, the candidate must go into Menu and enter his/her personal data by following the instruction; then, by selecting LOGIN from the Menu and entering access data received by the system, login to the personal area and proceed with the application.

Candidate already registered at Politecnico di Bari must select from the Menu LOGIN and login to the personal area by using his/her access data. Candidates are invited to update personal data in Home section, in particular e-mail address, as it will be used to send communications about this competition.

At this point, applicant has to click from the menu on the left on SEGRETERIA, then TEST DI AMMISSIONE, and the competition of this Call.

Applicant must:

- Select the language (Italian, English or French) he wants to use for competition examinations, enter his/her graduation data and follow the instructions of the IT platform;
- Select the category: *EU citizens*
- Attach documents, self-certification by using the template of Politecnico di Bari and available on the web-site www.poliba.it, *Didattica /Offerta formativa/Specializzazione*, required academic qualifications and identification document.

Academic qualifications and documents must be attached in PDF format. Each file to be uploaded cannot be larger than 5MB. The file has to be named possibly with applicant surname and type of qualification (i.e. rossi_curriculumvitae).

Applicants with a disability (according to law n. 104/1992 supplemented by law n. 17/1999) or with specific learning difficulties – DSA (according to law n. 170/2010) must make explicit demand in the online application of the needed support, and the possible need of the additional time for carrying out the tests.

Pursuant to D.P.R. 445/2000 and subsequent amendments, Italian and EU citizens must provide only the self-certification of qualification about status and facts certifies by Public Authorities for the following cases:

- a) registration in a professional registry belonging to Public Authorities;
- b) membership to a professional association;
- c) education qualification, examination completed;
- d) professional qualification, title of specialization, qualification, training, updating and technical qualification;
- In order to apply for the competition, applicants must pay fee of € 25,00 by using the online procedure PagoPA available in section "pagamenti" of his/her personal area in Esse3.

 In case of non-payment of this fee within the notice deadline, applicant will be excluded from the competition.

Candidate must attach to the admission application:

- *Curriculum vitae et studiorum* duly signed and dated according to Form "Modello 1" prepared by Politecnico, available on the website www.poliba.it path *Didattica e Studenti/Offerta formativa/Specializzazione*;
- valid identification document, currently valid and duly signed;
- 1st cycle three year degree and 2nd cycle two year degree (or single cycle five year degree) awarded, with final grade and mark of each exams in both study program, by filling in the form (Modello 2) prepared by Politecnico, on the website www.poliba.it path *Didattica e Studenti/Offerta formativa/Specializzazione*;
- Dated and signed self-certification of qualification (art. 46-47 of Presidential Decree No 445 of 28 December 2000) about possible qualifications, indicated in the CV among qualifications of point a) c) d) and e) of next art. 6 and to be used for the evaluation, by filling in form "Modello 3" prepared by the Politecnico, available on the website www.poliba.it path *Didattica e Studenti/Offerta formativa/Specializzazione*. (Pursuant to art. Law. N. 15/2011, candidate cannot provide certificates issued by Public Authorities concerning education qualifications in order to be evaluated. These certificates must be replaced by self-declaration according to above-mentioned art. 46-47 of Presidential Decree No 445 of 28 December 2000).
- graduation thesis of 2nd two year cycle degree (Laurea magistrale/specialistica)
- -Potential scientific publications (even the abstract) concerning the activities carried out and reported in CV;
- Potential foreign language certification (please read the next art. 7, III cpv.)
- Declaration about the choice of curricula (A, B, C) candidate wants to attend.

These documents must be in Italian or French or English language, or translated in Italian or English and legalized by Italian diplomatic or consular representation of the related Country, according to the current rules about the admission of foreign students to Degree programme of Italian Universities (MIUR note ref. n. 602 under the responsibility of the candidate).

The closure of the online application is successfully submitted only if applicant is able to print the PDF application at the end of the procedure;

Application cannot be changed anymore after his confirmation and submission; it will be possible to add, delete or replace documents attached only within the notice deadline. After the notice deadline, no further documents can be submitted.

After the notice deadline, the Administration will verify the validity of applications and completeness and regularity of self-declarations applicants have submitted. If applications or uploaded documents are not valid,

incomplete or irregular, the candidate will be excluded from the competition and the communication will sent to the e-mail address indicated in the application.

Incomplete applications or without the documents required by the notice will be excluded.

In case of scientific publication larger than allowable MB or not available in electronic form, candidate can send them by mail them separately, in hard copy or on CD o DVD-ROM supported by a list of publications within 12:00 a.m. of the deadline day for submitting applications.

In this case, the envelope, duly closed and signed across the seal, containing hard copy of scientific publications (that are not available in electronic form) or on a data carrier can be send by post, express courier to the following address: Magnifico Rettore del Politecnico di Bari – Direzione Gestione Risorse e Servizi Istituzionali – Post-Lauream - Ufficio Protocollo – Via Amendola 126/B, 70126 BARI.

Candidate must write on the envelope name, surname and lettering:

Art. 5 Competition for non-EU citizens: application submission procedure and completion

Competition for non-EU citizens is only based on qualifications with separate ranking list.

Non-EU citizens must apply for the Specialization School from October 6, 2018 and not later than 24:00 of November 5, 2018 only through the application available to web-site www.poliba.it, path DIDATTICA – PORTALE DEGLI STUDENTI ESSE3.

All communication about this competition procedure will send by e-mail to the address indicated in the application form.

Any applications submitted in different ways will not be taken into consideration.

Candidate has the responsibility to verify the correct conclusion of the application procedure. Applicants are invited to apply for the competition sufficiently in advance before the deadline

In order to access to the online application, the candidate must first register to ESSE3 system. In case the applicants have never registered at Politecnico di Bari, the candidate must go into Menu and enter his/her personal data by following the instruction; then, by selecting LOGIN from the Menu and entering access data received by the system, login to the personal area and proceed with the application.

Candidate already registered at Politecnico di Bari must select from the Menu LOGIN and login to the personal area by using his/her access data. Candidates are invited to update personal data in Home section, in particular e-mail address, as it will be used to send communications about this competition.

In particular, non-EU candidate or candidate with academic qualification awarded by a non-EU nation must upload documents issued by University where the qualification has been awarded:

- Certificate/University degree (1st level or 2nd level) with graduation grade.
- Certificate about passed exams of degree course(1st level and 2nd level) with mark.
- Any other document candidate wants to use for the purpose of the declaration of suitability/equivalence with qualifications as indicated in art. 3 of this competition notice (Diploma supplement, Declaration of equivalence).
- Curriculum vitae et studiorum duly dated and signed according form "Modello 1" prepared by Politecnico, available on the website www.poliba.it, path *Didattica /Offerta formativa/Specializzazione*.
- valid identification document, currently valid and duly signed;
- graduation thesis of 1st three year cycle degree and 2nd two year cycle degree;
- Certificate about other potential qualifications;
- Motivation letter to attend the Specialization School;
- Letter of introduction by a university Professor who has followed the candidate during his/her university studies.
- Potential scientific publications (even the abstract) concerning the activities carried out and reported in CV;
- Potential foreign language certification.

This documentation must be in Italian, in English or in French, or translated into Italian or English and legalized by the competent diplomatic representations or Italian consulates, according to the rules regarding the admission of foreign students to Italian universities (Ministry note Prot. 602 of 18.05.2011).

The online application is intended to be correctly concluded only when, at the end of the procedure, the candidate can print the PDF of the application generated by the computer System.

After the data confirmation and the electronic forwarding, it will no longer be possible to modify the application; instead, it will be possible to add, delete, replace or modify the attached documents provided until the Call deadline.

No additions to the documentation will be allowed after this deadline.

Verification of the validity of the applications, including the completeness and regularity of the self-certification made, will be carried out by the administration after the Call deadline. In the event of invalidity, incompleteness or irregularity of the application or documentation submitted, the applicant shall be excluded from the competition, with notice to the e-mail address indicated by the applicant in the application for Admission. Incomplete applications or without the mandatory qualifications required by this call shall not be deemed valid.

In case of publications exceeding the allowed MB or not available in electronic format, the applicant may submit them separately, in printed form or on CD or DVD-ROM accompanied by a list, within 12.00 am of the deadline date for applications submission for admission, by sending a proper parcel.

The delivery on timely manner of the parcel with the publications, by postal service, private courier, delivery agency at the University is at the sole risk of the Candidate.

The qualifications assessment will be carried out according to predetermined criteria as follows:

A thesis in discipline related to historical-archaeological or restoration topics: from 0 up to 8 points;

- B. Graduation Rating: 3 for a score from 105 to 109; 5 for full Absolute votes; 7 for full absolute votes with equivalent praise or vote;
- C. Scientific publications in matters considered by the selection board, relevant to specialisation: from 0 to 20 points;
- D) participation in archaeological excavation missions, surveying and study of monuments: from 0 to 15 points;
- E) other securities considered by the selection board, relevant to specialisation (documented experiences of restoration, cataloguing of cultural heritage; attendance certificates at master classes or related masters, attested knowledge of Further foreign languages than those foreseen in the contest access requirements, etc.): from 0 to 10 Points.
- F) Letter of Motivation: from 0 up to 5 points;
- G) presentation letter: from 0 up to a 5 points;

Candidates obtaining for the qualifications assessment at least 18 points on 30/30 are eligible.

Art. 6 Date and venue of the exam

In the days following the deadline of the Call, the dates, time and venue of the exams will be published on the University website www.poliba.it, and precisely on the online noticeboard of Politecnico di Bari (path: Bandi e Concorsi/Albo Ufficiale on-line), in the special section of the Specialization school, to the Path: http://www.poliba.it/it/didatticaestudenti/offertaformativa, on Specialization school site (www.specializzazionepoliba.it), as well as on the department site (dicar) where the school asserts, This publication will have a value of official personal notification to all interested candidates, exempting Politecnico di Bari from sending any Communication.

Art. 7 Qualifications assessment and exams

Without prejudice to the provisions of article 5, the competition for admission to the Specialisation school in architectural and landscape heritage is for qualifications and Examinations.

Candidates who, in relation to the number of positions available and in a useful position in the ranking list, are allowed to attend the School. In case of scoring parity precedence will be given to the youngest candidate.

Access to the admission exam is subject to the submission of a certificate of knowledge of a foreign language: English, French, German, modern Greek; alternatively it is possible to pass an oral exam allowing the verification the knowledge of one of the foreign languages allowed. For the purposes of the ranking issue, the Board of Examiners has at its disposal 100 points for each candidate, 30 of them for the qualifications assessment, 35 for the evaluation of the written exam and 35 for the evaluation of the Oral exam.

The admission exam consists of:

- a written exam concerning History of ancient Architecture and Architectural restoration and Landscape.
- an oral exam on the main issues related to the three curricula activated by the School

The qualifications assessment shall be carried out before the written exam and shall be known before the correction thereof, in accordance with the following predetermined Criteria:

- A) thesis in subjects related to historical-archaeological or restoration topics: from 0 up to 8 points;
- B) Graduation mark: 3 for a score from 105 to 109; 5 for full Absolute marks; 7 for full absolute marks with praise:
- C) Scientific publications in matters considered by the Board of Examiners, relevant to specialisation: from 0 to 20 points;
- D) participation in archaeological excavation missions, surveying and study of monuments: from 0 to 15 points;
- E) other qualifications considered, by the Board of Examiners, relevant to specialisation (documented experiences of restoration, cataloguing of cultural heritage; attendance certificates at master classes or related masters, attested knowledge of further foreign languages than those foreseen in the competition access requirements, etc.): from 0 to 10 Points.

Candidates obtaining the qualifications assessment at least 18 points out of 30 are admitted to the written exam. Candidates obtaining the evaluation of the written exam at least 21 points on 35 are admitted to the oral exam. Candidates obtaining the evaluation of oral exam at least 21 points on 35 are Eligible.

The final ranking will be drawn up according to the sum of the scores individually obtained in the qualifications assessment and in the respective written and oral exams. In any case, candidates who do not receive disclosure of exclusion shall be required to present themselves on the day, in the hour and at the venue of the examination exam.

The absence of the candidate for one of the exams will be considered as a renouncement of the competition, whatever the cause may be.

Applicants will be eligible to attend the exam bearing the same i.d. included in the online application.

During the exams, applicants, on penalty of exclusion, must use only a black ink pen, they will not be able to hold bags or backpacks, nor will they be able to use writing paper, notes, books or publications of any species, Electronic equipment or computer tools and cellular telephones, nor will they be able to communicate with each other verbally or in writing, or relate to others, except with the supervisors or with the members of the Board of Examiners. The candidate not respecting the preceding provisions shall be immediately excluded from the competition by the Commission. The non-exclusion at the time of the exam does not preclude that it may be disposed at a later stage. The Board of Examiners shall ensure compliance with the above provisions and shall take all necessary measures.

Art. 8 Board of Examiners

The Board of Examiners, appointed by Rector's Decree after the deadline of submission of the application, is made up of the Director of the School and four tenured professors, and their deputies, appointed by the Council of the School.

Art. 9 Publication of the results and fulfilments for the enrolment

After the competition and all the formalities are completed, the official ranking (R.D. Approval) will be published on the on-line Official bulletin-board of Politecnico di Bari (www.poliba.it/Bandi e Concorsi/Albo Ufficiale on-line) as well as in the special section of the Specialization School, to the path: didattica > offerta formativa > specializzazione, and it will have official notification value.

Candidates admitted to the school must send to the Rector of Politecnico di Bari, Post-Lauream Office: Application for registration at the Specialization School, together with the prescribed documentation, following the instructions that will be provided, immediately after publication of the ranking referred to in paragraph 1, and published in the special section of the Specialization School, to the didactic path > training offer > Specialization, with official notification value.

After verifying the regularity of the documentation and after the necessary verifications, the university will preenrol the winners of the competition, on a web platform in ESSE3, giving notice to them, and the Pre-enrolment will allow access to the course.

The enrolment will be concluded after the payment -in the prescribed time- of the taxes, stamp and contributions referred to the following art. 10, using the appropriate procedure of the online payment system Pagopa.

As a result of any funding obtained from public and private bodies, scholarships could be allocated to the students admitted to the school, according to the ranking list approved and to the sums allocated.

Art. 10 Fees and contributions.

Fees and contributions for enrolment in the school are set at €1500.00 annually.

All students are also obliged to pay the annual stamp, amounting to EUR 16.00, and the regional tax for the right to study (Adisu/Politecnico), amounting to 160 euros.

The total amount due for tuition fees and contributions of each year shall be paid in two half-yearly instalments: The first at the time of enrolment, the second by the following 30th June.

Art. 11

Formality of renouncement after the enrolment.

Students who, after the enrolment, decide to interrupt their studies at the school must go to the Post-graduate office and submit a written declaration, with \in 16.00 official stamp, addressed to the Rector. The renouncement can be made at any time. Students renouncing to continue their studies are not entitled to tax reimbursement and contributions already paid.

Art. 12

Prohibition of simultaneous enrolment

The attendance of the school of specialization is not compatible with the participation to other courses of study of any order and degree.

The attendance of other courses of study, such as the PhD course, involves the suspension of the school of specialization for the duration of the relative course.

Art. 13

Calendar of the activities and final exam

The attendance of school activities is mandatory; the student is obliged to follow all the lessons and tests of each course and of the activities envisaged. Attendance verification will have to certify an annual participation of not less than 75% for each teaching course.

The final exam is aimed to ensure the proper preparation of the students enrolled in the courses of study to obtain the relative educational credits.

In order to pass the exams or other forms of verification to acquire the relative educational credits the student must have obtained, in the course of study to which it is enrolled, the certificates of attendance and also to be in compliance with the payment of the taxes and the Contributions due.

The school makes known to the students enrolled, the calendar of the exams at the beginning of the didactic activity, providing an exam at the end of each didactic period in which the academic year is articulated.

The final exam commission is made up of course teachers or, in the case of integrated courses, by the teachers responsible for the training activities.

The results obtained in any internships or placements will be assessed by the teacher or by the teachers responsible for the same internships.

Those who do not pass all compulsory basic examinations of their course cannot be admitted to the following year and must repeat the year. The student may not enrol more than twice to the same year. At the end of the two years and for the achievement of the Degree of specialization, the student will have to write an individual thesis on a theme agreed with the school council and under the supervision of a teacher of the school who will be the Thesis Supervisor. The thesis will be defended in front of a commission of 7 teachers of the school and will report a vote in seventeenths. The examination is intended to be passed by a minimum vote not less than 6/10 of the maximum vote expressed by the Commission.

Art. 14 Publicity

This Call is published in the official noticeboard of Politecnico di Bari (www.poliba.it/Bandi e Concorsi/ Albo Ufficiale on -line), in the Department website (at Research/Departments, School: Didattica/ Offerta Formativa/Specializzazione) and on the Specialization School website (www.specializzazionepoliba.it).

All subsequent documents linked to it will be made public by official publication in the official noticeboard of Politecnico di Bari, with official notification value for all the interested parties.

Art. 15 Personal data processing

For the purposes of Law no 675/96, the confidential nature of the information provided by each candidate shall be respected. All the data provided will be processed only for the connected and instrumental purposes to the competition and, for the winners, for the purposes related to the School activities, in compliance with the current provisions of the RGDP Regulation UE2016/679. In any case, participation to the competition implies, respecting the principles laid down in the aforementioned law, an expression of tacit consent that the personal data of the candidates and those relating to the insolvency tests are published on the site/portal of the University. Under the law of 7 August 1990, no 241 and of the DPR of 12 April 2006, no 184 and S.M.I. the right of access to the competition documents is guaranteed to anyone who has a legally relevant interest in, to be practiced in the

legal terms, and therefore the competition documentation submitted may be subject to access by other Applicants.
